
Sir,

In this connection the Commission requires detailed information from the State Government on the resources and committed liabilities, including those on account of establishment costs, expenditure on maintenance of capital assets and on Plan projects, with clear segregation of non-salary/non-wage related expenditure, and forecasts of revenue receipts and plan and non-plan revenue expenditure for the period 2015 – 2020.

I am, therefore, to request you to kindly submit the consolidated information as per relevant proforma in the CD enclosed for the Heads of Account with which your Department are concerned at the earliest possible but not later than 28<sup>th</sup> February, 2013 to enable this Department to scrutinize and compile the same for submission to the Finance Commission.


