OFFICE MEMORANDUM

Subject :- Merger of 50% Dearness Allowance with basic pay/basic pension of Meghalaya State Government employees with effect from 1st April, 2005 – Ceiling of DCRG.

Consequent upon the implementation of the merger of 50% Dearness Allowance with the Basic Pay/Basic Pension vide O.M.No.F(PR)-15/97/Pt/507 dated 20.12.2005, in which Government had decided that the component of Dearness Pay would be counted for the purpose of retirement benefits, the Governor of Meghalaya is pleased to say that the rate of D.C.R.G./Retirement Gratuity shall continue to be paid @ equal to one-fourth of a Government employee's emoluments for each completed six monthly period of qualifying service, subject to a maximum of Rs.3,50,000/- (Rupees three lakhs fifty thousand).

The amount of gratuity shall be rounded off to the next higher rupee.

2. This partially modifies para 7.1. of this Department's O.M. No.F(PR)-102/97/4, dated 12th January, 1998.
3. This order shall take effect from the 1st April, 2005.
